Be In Christ Church of Canada - Senior Resource Team Report

As the Executive Director I am deeply pleased with the work that has been taking place since we last met as a national church body.

This past year has been a season of adjustment for me. Due to an unexpected health issue in November, my schedule had to shift for various tests and, frankly, to rest. In the midst of something that was unexpected and “unwanted” much good has come forth...

- I had to learn the art of patience
- I had to learn what it meant to be dependant in a real way
- I had to learn what it meant to not be fully independent.

SO, in all of this, I think of the words of Paul in I Thess 5: ***Be thankful in all circumstances. This is what God wants from you in your life in union with Christ Jesus.***

So let me begin by giving thanks to significant people who make my life and work better...

First, my family. Every year I grow in my love and appreciation of my family. I am a blessed person. My family's love, patience, and healthy independence allows me to do the work I have been called to do. They speak truth into my life, challenging me in both my faith as a follower of Jesus and in my leadership. They are a funny gang who help keep life real! Thank you Tonya (spouse), Prestyn, Grace-Anne, Ashly, and Carter. Next to Jesus, you are the greatest gift I have received. Thank you for your love and presence.

Second, our pastoral team. I am impressed by their love for the people they serve and their desire to do so in the way of Jesus. As a church we are striving to be led by transformational leaders. Our pastoral team has led well this past year... loving their people and serving their communities. Thank you for your partnership!

Third, the team of people I work with daily. I am grateful for (and proud of) their desire to support and serve our people, pastors and churches well. They work hard and put in long hours to help our churches move forward in mission. They are committed to helping all of us live out what it means to be ***incarnational churches led by transformational leaders***. In the midst of moving mission forward, they deal with massive amounts of detail and do so in a kind way and with a servant mindset. Thank you!

In 2018 our network of churches accomplished much together. We have a team of people - pastors and leaders - who are committed to the challenge of seeing us continuing to become a growing faith community, following Jesus, sharing his message and extending his peace around the world.

So let me highlight a number of key areas:

Operations

- Nationally, staff works hard to resource our churches well and help move local church mission forward.

-
- 27 Churches/organizations are currently use our denominational payroll system. This assists churches, helps them focus on their mission and ensures compliance with all rules regarding payroll in Canada. We continue to serve our pastors and staff with a robust pension and benefits plan.
 - Our office assists local churches with CRA compliance, credentialing, building and compliance issues, help with immigration for our US based pastors, evaluations and placement, and a host of other things.

Communications

- Communications continues to be an area of high significance as we aim to share clearly and concisely the message of the work to which God is calling us. We desire to steward well and communicate widely the stories of our communities to encourage and share what God is doing among us.
- We manage multiple websites. At this point, the four that are public would be www.canadianbic.ca and www.thepastoralway.com, www.flowinternship.com and www.theibica.com.
- Online our Appetizer is well received and social media posts continue to generate discussion.
- We continue to post videos of our resource (LEAD) events and see them accessed.
- Each year we print The Dinner Table, an Advent Devotional and Lent Resource.
- We have partnered with the US with Shalom magazine. Each edition will be sent to all our Canadian pastors and we will be providing a Canadian perspective or author in each issue. Shalom is a magazine that writes in the area of peace and social justice.

Congregationally

- Our churches are doing well. We hear stories of life change and transformation occurring in all of our different expressions and for this we give thanks.
 - Our churches baptized 193 people - this is not just a statistic, but a number representing lives changed by Christ.
 - In total, the people of our churches gave about \$16,000,000 to the work of their local churches. Generously our churches gave over \$1,050,000 to the work of the Church in Canada, about \$650,000 to our global ministries and another \$850,000 to ministries such as World Vision and MCC.
 - Almost all of our pastors participate in a pastoral cluster group (these look different from expression to expression) for development, accountability and relationship building.

-
- o Our Churches continually prioritize serving their communities through ministries that reach into the community and serve people. It can be through VBS's, Divorce Care, Grief Share or Repurpose. These are just a few examples.
 - o Church planting continues to move forward - we celebrate what God is doing through the Reunion Network. In 2018 we welcomed Reunion Kuwait... See www.reunionkuwait.com
 - o We recognize that patterns which have been historic are beginning to shift. Attendance, giving, serving, and membership are just a few examples of areas where change is beginning to take place. As a denomination, most of our churches have tended to not have been impacted negatively by these trends, but we know we are not immune to long-term social/cultural shifts. Therefore, **mission focus, training and conversation on these issues as congregations and pastors is important and a priority.**
 - o In all of our expressions we continue to see growth in the number of younger pastors coming on board. This is important; as this trend continues, we will likely continue to see healthy diversity in how we talk about issues, lifestyle choices, etc.
 - o The Meeting House is in the early stages of a rebranding experience. We look forward to seeing that unfold. As part of this process, they have adopted a new vision statement: **To introduce spiritually curious people to the Jesus centred life, through a movement of Jesus centred churches. Right now. For real.**

Jesus Collective

- The Meeting House (TMH) is now in the pilot phase of Jesus Collective. The Jesus Collective is *"a group of Jesus followers who believe the time is right to unite, equip, and amplify a movement that is all about Jesus. We believe a more connected, relational network of churches and leaders could give greater unity, voice, and visibility to this Jesus-centred, third-way movement, develop and support future-ready leaders, and equip more churches to make more disciples in a post-Christian context."*
- As part of the Collective, TMH is welcoming two churches from our Community Church family – Faith Community Church in Alliston and West Lake Community Church in the Sandbanks, ON area – as Meeting House Extended Family Churches. These are existing BIC congregations that have been tracking with TMH for some time. We celebrate this partnership and expression of kingdom work.

Emerging Issues:

Over the next 12 – 18 months we will be working and talking together on a number of key issues and initiatives such as:

- Engaging our Next Generation
- Engaging our Global Family
- Expanding our Church Network

-
- Equipping our Leaders
 - Embracing our Identity
 - Engage globally in an increasingly flat world which is well connected. Our newest congregation is in Kuwait. See www.reunionkuwait.com

Finally, as I close, I want you to know what a joy it is to serve you the people of the Be in Christ Church of Canada. We are blessed with people, churches, pastors and leaders who have a clear heart for the kingdom of Jesus. It is a joy to see us all work to live out our purpose of being a people committed to following Jesus, sharing his message and extending his peace around the world. It is a joy to see it lived out contextually across the country as churches seek to serve their communities well.

I close with the words of Paul, *"We (I) always thank God for all of you and continually mention you in our prayers. We (I) remember before our God and Father your work produced by faith, your labor prompted by love and your endurance inspired by hope in our Lord Jesus Christ."* (1 Thess 1:2-3).

BIC CANADA-GLOBAL

Introduction

The people and churches of Be in Christ Church of Canada continue to demonstrate an avid and compassionate heart for the global church family. Our churches have a desire to impact people around the globe with the love, compassion and hope of Jesus Christ. It is our desire as Be In Christ Canada to walk with our churches to help them accomplish their goals for global impact and mission. We believe strongly that there is no limit to what our God can and will do, and we are seeing the work of His hand in the lives and ministries of our siblings around the world. We echo Jonathan's armour-bearer. **"Do everything that is in your heart and mind; here I am with you in whatever you think best."** | Samuel 14:7. This is our desire as a team.

As we serve our sisters and brothers, we want to do so in a way that honours the culture of the countries with whom we engage. We are attempting to take a servant role in assisting with projects and work born out of local knowledge.

As BIC Canada-Global it is our belief that we as a people and a church are called to extend Jesus' message and compassion around the world. As such, we continue to work in four key priority areas:

- Leadership Development
- Church Planting and Evangelism
- Compassion Engagement
- Learning and Listening to our sisters and brothers around the world

What We Do

When one looks at the global church and our relationship to it, we primarily work through our local partners - fellow BIC Churches around the world. In terms of what we did together... a sampling would include:

- We supported students in theological training in both Malawi and Zambia
- We purchased bicycles for students in theological education in Zambia
- Partnered with the Cuban Church in support for Church Planting, transportation for pastors to their Annual Meeting and support for their national office.
- Partnered with the Nicaraguan Church in the completion of their national ministry centre and began working on the attached dormitories.
- In Nepal and Odisha India we supported a total of 25 Church Planters / Village Workers
- Supported approximately 50 children through the Spice Program
- Supported the Nepalese Church in the beginning of the PEACE (Providing Essential Assistance for Children's Education) Program. 59 Children were supported through this initial investment.

Addressing Suffering

A major reality for a number of countries around the world has been suffering as a result of either natural causes or political realities in the area. We recognize that we are not a relief and development agency, but what we can do is provide immediate support in times of crisis and pain as sisters and brothers. So in 2018 through BIC Canada-Global and the World Hunger Fund we provided assistance to the following:

- Our Venezuelan sisters and brothers who serve as pastors who are leading in the most challenging of circumstances and inadequate resources.
- The Nicaraguan Church as a symbol of solidarity with them in the midst of political turmoil and inflation.
- Support for a Bishop in desperate need of medical assistance.
- Support for hunger relief in Malawi, in partnership with the BIC US Church.

Whenever I interact with our sisters and brothers around the world, I am reminded of how blessed we are as a people and a church in Canada. We need to give thanks to God for our reality. I am grateful to lead a church that cares and is willing to invest generously in the needs of people who love Jesus around the world and are suffering.

Local Church Investment

We also celebrate the way in which our local churches are directly supporting the work of the global church beyond simply giving to our shared budget. We celebrate that:

- Four churches in Canada have chosen to support four church planters in Cuba. This allows the Cuban Church to expand into three provinces in which they have had no formal presence. - Our churches did a combined total of 8 trips working with partner churches around the world. More than 70 people went on these trips. Countries included places such as Cuba, Haiti, and Southern Africa.
- Together over 1,700 Relief kits for MCC were produced. These kits are deployed around the world to places in distress at times of need. Just this April a bin of relief kits was delivered to Malawi to provide food and basic necessities for living.
- Together our churches and people gave over \$17,000.00 to the World Hunger Fund and over \$640,000.00 to BIC Canada-Global. Beyond that, our churches gave another \$849,000.00 to organizations such as MCC and World Vision.

Global Workers

In 2018 we supported three families or individuals working in Zambia. The Percys and Sanfilippos continued to serve at MICS (Macha International Christian School). Their work involved administration, facility development and teaching. At the conclusion of 2018 The Percys transitioned in their roles. Julianne continues at the school in her role and Joel handed over his administrative role to a Zambian national. As a family, they continue to live in Macha. Amanda Schwartzentruber is deployed to the Macha Hospital as a paediatric nurse. The hospital is both a treatment centre and research facility in the area of HIV/AIDS and Malaria.

We are grateful for the dozens of people who support(ed) the work of these global workers. Without your prayer and financial support, we could not deploy them successfully. As the Be In Christ Church of Canada we provide 15% of their deployment budget plus administrative support. Thank you to each person or church who has invested in their work over the past year.

The Future

Our work continues to grow. Over the past four months we have been processing a number of opportunities outside our ordinary work:

- 1. The Nepal P.E.A.C.E. Project.** Currently, we are working with the Nepalese BIC Church in assisting with the education of 59 students. It is our hope to see this increase to approximately 100 students by the end of May 2019. This is an investment in a new generation of persons in Nepal and a partnership driven by their objectives that match our missional desires in compassion engagement.
- 2. International Brethren in Christ Association (IBICA).** We continue to give leadership in this developing ministry. I serve on the Executive Committee. We will be hosting about 25–30 international leaders from IBICA this November. If your church would have interest in one of these national leaders visiting your congregation please email: charmaine.stulp@canadianbic.ca
- 3. The Rwanda Brethren in Christ** is a young church in the process of being established. It developed out of a relationship from a Meeting House site. IBICA has been working with this young church and is asking Be In Christ Canada to consider sending someone to Rwanda for up to 6 months to help with conference formation and leadership development. - 4. Haiti.** Two of our churches (Sauble and New Hope) have been working in Haiti for a number of years. The church in Haiti is looking for affiliation and to become Brethren in Christ. Because of our connections the International Brethren in Christ Association has asked us to be their sponsor and mentor for the next number of years.

As a Church we have much to celebrate in our global work together and as individual churches. Our work together is sharing the good news through word and deed. When I think of the work that has been accomplished I am reminded of what Paul wrote in Gal 6:2 - *“Bear one another’s burdens, and so fulfill the law of Christ.”* As a church, you have done well bearing the burdens both spiritual and physical of our sisters and brothers around the world. It is a joy to serve you in this work.

BOARD OF DIRECTORS REPORT

A. General

"So Jesus called them together and said, "You know that the rulers in this world lord it over their people, and officials flaunt their authority over those under them. But among you it will be different. Whoever wants to be a leader among you must be your servant, and whoever wants to be first among you must be the slave of everyone else. For even the Son of Man came not to be served but to serve others and to give his life as a ransom for many."

The Board of Directors exists to serve the church in Canada through governing and overseeing its operations between the meetings of the members of Be in Christ Church of Canada. They work within the parameters of the General Operating Bylaw One and any motions passed by the meeting of the members (AGM). They carry the responsibility for oversight of Senior staff and to ensure that fiduciary and any regulatory obligations are met by either board committee or staff. The current Board of Directors is made up of 10 people. Members of the board currently are involved in either Community Churches or The Meeting House and equally female and male.

In 2018 we met on five different occasions two of which were in person and three by video conference. In 2018 a number of actions were taken:

- Acted as the nominating committee, recommending names to the 2018 AGM for the Board of Directors.
- Received financial reports for 2017 year end.
- Approved the necessary motions for the 2018 Annual General Meeting
- Approved the two new strategic initiatives and strategic plan
- Approved the transfer of funds to the Ontario Conference of the Mennonite Brethren related to the sale of property
- Approved new Bylaws for Camp Kahquah
- Approved an updated Employee Handbook, denominational privacy policy, and the Discipline and Reconciliation Manual
- Approved facility improvement or construction requests for Sauble Christian Fellowship and Welland BIC Church
- Received updates on Timber Bay Children's Home and The Jesus Collective

The work of the denominational board is similar to the work of a local church board in that we are concerned about the ongoing health and effectiveness of our network/family of churches. It is different from a local church board in that a diverse group meets several times a year and deals primarily with administrative proposals brought from the Senior Resource Team or the Executive Director. This group has been a team of committed individuals.

I have served in the role of chair for the past six years. I conclude my time - grateful for the experience and with a deeper appreciation for the work of the church across Canada. Over this time, the board and I have appreciated your trust and the health of our denominational family. As a board, we together are grateful for the growth we see happening in all the expressions - Community Churches, The Meeting House and within The Network. God is at work among us and are grateful for His presence among us.

On behalf of the Board, it has been a joy to serve you this past year.

B. Financial

Be In Christ Canada - Financial Report

The attached financial reports demonstrate the ongoing generosity of our people and churches to our work together as a family of churches and the denomination. Thank you for your consistent and generous giving to our work together. We see it in support for local churches, in volunteer hours to ensure ministry happens at both the local church level and then into the broader community. We see it as many of our churches invest much time in putting together MCC Relief Kits, serving in local food banks, thrift shops or other places of community impact. We see this generosity in both local church giving and individual giving to the work of Be In Christ Canada.

As can be observed, it appears we ended the year with a loss of approximately \$81,088.00. However this was the result of a decision to not transfer over from our reserves what we had budgeted (we had planned on drawing \$200,000 but instead only drew down \$75,000.)

Expenses were largely in line with what was expected. Overages did occur in two categories. Conference office exceeded its budget by about 8% due to the need to replace a number of pieces of office equipment because of the reallocation of office space. Community Church exceeded its budget due to staff changes that saw the Team Leader return to full time status in July of 2018.

In way of general highlights:

- General shared giving surpassed \$1,000,000 for the third year in a row. And exceeded our budgeted plan by \$19,000.
- Designated contributions – direct giving from people, bequests or other organizations – were below what our budgeted estimate was.
- On the expense side, certain categories exceeded the budget and others were lower than expected.
- In total, expenses were about \$70,000 above expected, while income was below our budgeted amount by about \$43,000 but would have exceeded what was planned by \$82,510 if we had transferred the full budgeted amount from reserves. We did not do so because we didn't need to do so as a result of healthy cash flow.

We continue to encourage churches and treasurers to send in their shared giving contributions on a monthly basis. This helps our broader family manage its finances in a healthy way. It is no different than in a local church where we encourage people to give on a regular basis. Your continued help with this as local congregations is appreciated.

To each church and person who has given to the work of Be In Christ Canada - thank you! The work that is accomplished is our work together. As a denomination we are so grateful for the generous support of our people and our churches. Thank you!

BIC Canada-Global - Financial Report

BIC Canada-Global finances are more complicated than those of Be In Christ Canada due to the nature of deployed staff and their funding requirements. Throughout 2018 there were three staff families deployed overseas, plus the funding income for associate global workers. In 2018 total net expenses exceeded income by just over \$4,000.

Again, we celebrate the generosity of our people. In 2018, giving to both our Core Activities and Vision Activities exceeded our planned budget by a total of \$138,000. This is the result of generous giving by our churches and the people of Be In Christ Church of Canada to projects around the world and support for our global workers. This is a reflection of the passion of local churches for what God is doing around the world. For example, churches are supporting church planting in Cuba, constructed a dormitory for the ministry centre in Nicaragua and are supporting water projects in Zambia. These are just a few examples of the ways in which the congregations of Be In Christ Church of Canada are investing in the global church. We celebrate this.

FINANCIAL RECOMMENDATIONS:

1. SPENDING PLAN 2019

Be in Christ Church of Canada Proposed Spending Plan 2019

Notes related to income:

1. Shared Giving: This is basically the same as was given in 2018 by our congregations.
2. Transfers: We are working to reduce long-term dependence upon reserves and transfers. This is a \$10,000 reduction from 2018.
3. Administrative Fees are fees assessed when handling funds for other organizations, designated giving to projects, etc. This income line is similar to what was received in 2018.

Notes related to expenses:

1. Mission Global: This represents about 12.2% of shared giving received by Be in Christ Church of Canada from our local churches. Our target historically has been 10%.
2. Mission Canada: This represents all the work that Be in Christ Church of Canada does nationally. This includes things such as pastoral training, church planting, cluster groups, the residency program, some communications pieces, pastoral reviews, church board assistance, student ministry, internships, support for Camp Kahquah, etc.
3. Mission Partnership reflects costs such as ADP (payroll services costs), legal fees, auditing fees, office expenses, software, and general church leadership.

ARCHIVIST REPORT

The major event in the Archives in 2018 was the move to the Port Colborne Be In Christ Church in July. Be in Christ Canada co-operated with the Port Colborne congregation in developing a much larger space for the Archives; thanks to our leaders for sharing some funding from the former Cheapside congregation to make this possible. We were able to collect all the larger items into one location! Thanks also to the two summer interns for packing the contents of the Archives. Head office gave the Archives several additional file cabinets, totalling fourteen drawers; this reduced the amount of material in cardboard boxes. We held an official opening October 27th. Small groups and individuals are invited to visit the Archives to learn more of our shared history.

The move seemed to encourage the donation of new items! The large soup cooker from the former Bertie congregation was installed, with a stove pipe so that it looks functional. The quilt made in Zimbabwe in recognition of the 100th Anniversary of BIC Missions in Africa was hung, along with other items which had been in storage. Additional copies of the 1935 brown hymnal were donated, as well as copies of the 1963 red hymnal. Camp Kahquah placed their historical records in the Archives, from 1962 forward; the new material is being integrated with the previous files for a permanent record.

The Archives has many resources, which people appreciate researching, or having the Archivist research: the presidents or principals of Niagara Christian Collegiate, a complete listing of all current or former BIC congregations and/or church plantings in Canada, the Baker family, the Bethel cemetery near Cheapside, a Bible at the Cross Roads Church, the particular John Winger family, anything on BIC military chaplaincy, another Anabaptist group in pioneer Niagara, the dates for beginning and constructions of the Welland Church. A BIC pastor from Japan was enthralled with all of the aspects of the Archives.

When cleaning out cupboards, files and attics, please send any and all materials connected to the history of the denomination to the Archives. If we already have the items, we are happy to recycle the paper; if not, you are adding to the historical record.

I continue to serve as the Canadian Representative for the BIC Historical Society. Please consider joining. Members receive three journals and three newsletters per year, as well as other books printed by the Society. In 2018, a copy of a fascinating book by E. Morris Sider, *STORIES AND SCENES FROM A BRETHERN IN CHRIST HERITAGE*, was provided to each member. Annual membership is just \$25.

Introduction

The BIC Fund is a ministry of the Be in Christ Church of Canada. You will find a general report below. With the necessity of reincorporation in 2014, the By-laws of the BIC Fund were adjusted as required. The major adjustment was to membership. The membership of the BIC Fund is now the denominational Board of Directors. As such, the AGM for the BIC Fund rests with the denominational Board of Directors. The BOD of the denomination provides the governance, oversight and receives the required reports including financial, etc. If you have any questions please feel free to contact Doug Sider or Bob Leadley at office@canadianbic.ca.

General Report

The ministry of Designated Interest continues to be a source of encouragement and enthusiasm. In 2018, \$29,443 was designated by twenty-one individuals to agencies and congregations of the denomination. We are sincerely grateful to the people who are devoted to furthering the work of the Church in this way.

Over the past five years, \$168,142 has been designated to the Ministries of the Church by BIC Fund depositors and Endowment Funds.

The total number of depositors in the BIC Fund at year-end was two hundred and sixteen (some with multiple accounts). We have two outstanding loans to congregations and agencies.

The rate paid to depositors at the beginning of the year was 3%, holding throughout the year. This rate has held since November 2011.

The rate charged to borrowers began the year at 5%, continuing to the end of the year. This rate has also held since November 2011.

Interest on all deposits and loans is calculated on the daily balance compounded monthly. The statement of funds on deposit (which is issued quarterly) is the record of liability to the depositor.

Becoming a credentialed minister is a high calling, with both privileges and responsibilities. Through the credentialing process, the Be in Christ Church of Canada recognizes someone as having theological and cultural fit with who we are as the Be In Christ Church of Canada, being of good character and having an individual commitment to continue to develop as a person, follower of Jesus, shepherd and leader.

In The Pastoral Way, we are calling all of our credentialed persons to be people that are characterized as lovers, leaders and learners.

- **Lovers:** We want to see all of our credentialed people growing in their love of God and the people they are called to serve.
- **Leaders:** We desire to see each of our credentials persons develop as leaders. Leadership is the desire to use one's gifts and strengths to see the organization they serve within grow and become the best version of itself.
- **Learners:** We desire to see each of our credentialed persons to be curious about the world, the church and their work. It is a desire to be constantly learning and growing in our understanding of the world.

We believe that having a credentialed clergy and pastoral team that models these three characteristics leads to a church and team that is full of health, vitality, vision, sensitive to the Spirit and voice of God and equipped and able to help each church become God's best version of themselves where they are. These three words are beginning to shape the way in which we do credentialing, hiring and pastoral reviews.

It is a joy for us as a church to work with the development of our pastors and those who hold credentials. Each person who holds credentials represents not just themselves or their local church. They represent who we are as Be in Christ Church of Canada and, more importantly, as Jesus. Investing well in the ones who represent us collectively is an investment worth making.

In 2018 we (Senior Resource Team) reviewed our credentialing process and made a number of adjustments to the credentialing process. This included adjustments to the initial credentialing form and changes to what we historically have called "Frosh" – a new credentialed persons' orientation. We believe our credentialed persons will benefit from meeting twice. In the new process, newly credentialed pastors will participate in Orientation 1.0 in their first year of service and then Orientation 2.0 their second year.

Let me encourage all of us to pray regularly for our pastors and credentialed persons. While we all serve Jesus, these persons serve in unique roles of leadership. Let's together entrust them to the Lord and his service among us.

PARTNER REPORTS

Simply put, *God is on the move!* We continue to feel growing affirmation for the vision behind a new relational network of like-minded churches and leaders, coming together to unite, equip and amplify a Jesus-centred, 'third way' movement. And we're calling this network Jesus Collective! While this initiative is being birthed out of The Meeting House, our vision is for a network that is much bigger than any one church or denomination. We believe Jesus Collective can be a place for us to look beyond ourselves and contribute what we can to the broader Kingdom, as well as create space for our own church and denomination to learn from and alongside the growing diversity of Jesus-centred church and ministry expressions in North America and beyond.

It's very early days for this fledgling network. We want to take a test and learn approach, discerning the Spirit's leading as we move forward. Jesus Collective has entered a pilot phase where we hope to learn more about the needs of this movement and level of interest in a network like this through a number of trial activities and engagements over the coming year.

The early response has been very encouraging. We recently hosted a Jesus Collective Sunday at The Meeting House, featuring a panel interview and passionate sermon by Greg Boyd, highlighting the opportunity we have to unite a growing Jesus-centred movement taking shape around the world. Also in March, representatives from over 50 Canadian and American churches and ministries gathered outside Washington DC to cast vision, share perspective, and pray for Jesus Collective. There is a high degree of enthusiasm and support for the Jesus Collective vision; perhaps the most encouraging sign being that both Anabaptist and like-minded non-Anabaptist churches and leaders are registering shared interest, in both Canada and the US.

Within the pilot we are also preparing the first iteration of a relational, cohort-based leadership formation community, other online and in person connection points for pastors and ministry leaders, and ways to experiment with ministry resource sharing among partner churches over the course of the coming year.

Most churches or ministries looking to partner with Jesus Collective will do so as separate organizations, with no expectation that they change their identity or affiliate directly with either the BIC or The Meeting House. But there are also churches and church plants that may be interested in journeying more closely with The Meeting House beyond the GTA/Hamilton corridor, where most of our current sites are located. We are excited to be experimenting with a new way to partner with these communities as well, providing a way to expand our Kingdom impact beyond our current geographical footprint. We're calling this branch 'The Meeting House *Extended Family*', and launched our first two pilot churches in early 2019 to begin learning about this new potential model. Faith Community Church is becoming The Meeting House Alliston, and West Lake Community Church is becoming The Meeting House Sandbanks. International Brethren in Christ Association (IBICA)



The International Brethren in Christ Association is a relational network of national conferences of the Brethren in Christ Church around the world. IBICA was established in 2006 and formally organized in 2009. The International Brethren in Christ Association exists to facilitate a common theological core, and build relationships among national member conferences - thereby encouraging and strengthening our common mission together to reach the world for Jesus.

In terms of work and outcomes, IBICA seeks:

- To help build relationships and healthy church-to-church connections within the global BIC community.
- To provide a place for the consideration of and speaking into issues of mutual concern and common interest – both theological and practical.
- To provide guidance and oversight in the establishment of new national conferences.

The IBICA is governed by a constitution and organized by an Executive Committee. The current Executive Committee is as follows:

- Bishop Thuma Hamukang'andu, Zambia
- Bishop Danisa Ndlovu, Zimbabwe (former bishop)
- Rev. Alan Robinson, USA
- Rev. Doug Sider Jr., Canada
- Rev. Bijoy Roul, Odisha, India
- Dr. Jose Otamendi, Venezuela

Over the past year, the Executive Committee met on 4 occasions - once in person and three times by video conference. The work of the Executive Committee the past year involved evaluation of and recommendations for changes to the Constitution, the approval of a job description for an Executive Director and the planning of the next national leaders' gathering (Nov 2019).

Each national church is asked to give at least 1% of general givings to the work of the IBICA. Since 2017, the Canadian church has budgeted about 3% of its income for IBICA. We believe that IBICA is a helpful vehicle to provide healthy church-to-church relationships and foster mutual learning and relationships between national leaders.

Over the past 6 months, IBICA has asked Be in Christ Church of Canada to take on a number of responsibilities.

1. They have asked us to consider sending someone to Rwanda for up to 6 months to help with conference formation and leadership development in this emerging Brethren in Christ Church. If you would have interest, please contact Charmaine at: charmaine.stulp@canadianbic.ca.
2. Two of our churches (Sauble Beach and New Hope) have been working in Haiti for a number of years. The church in Haiti is looking for affiliation and potential Brethren in Christ membership. Because of our connections, the International Brethren in Christ Association has asked us to be their sponsor and mentor for the next number of years. We have accepted this responsibility.
3. We have been asked to host the IBICA National Leaders' Gathering in November 2019. We have accepted this opportunity and are excited to host up to 30 international leaders. We will be hosting these bishops and leaders at **Camp Kahquah**. If you have interest in having a national leader visit your church, please let us know and we will work to make it happen. TERMS YOU MAY HEAR

Articles of Faith and Doctrine - The theological statements of the Church. The Articles of Faith and Doctrine make up section one of the Handbook on Faith and Life and are only amendable by the approval of the Annual General Meeting of Be In Christ Church of Canada.

Articles of Government - The policies and procedures which govern local churches, pastors, etc. The articles of government make up section 2 of the Handbook on Faith and life and are amendable by the Board of Directors.

BIC - Brethren in Christ - BIC Canada - this is the historic name of Be In Christ Church of Canada.

BIC Fund - The Brethren in Christ Fund - this is a separately incorporated entity which allows people to designate interest to Be In Church of Canada and provides short term loans to congregations for capital projects.

Board of Directors - The group that provides governance and oversight leadership in between the meetings of the AGM. Usually meets 3-4 times per year.

Camp Kahquah - A Christian camp owned by Be In Christ Church of Canada that hosts children, families and retiree retreats. It is located in Magnetawan, Ontario.

CCPT - Canadian Cuba Projects Team - A fraternal entity that works among the Hermanos en Cristo Church of Cuba.

Handbook on Faith and Life - The book which governs our work together as a church including our theological understandings.

General Operating Bylaw One - The operating bylaw which governs the functioning of the Be In Christ Church of Canada. It is only amenable by the annual meeting of the Be In Christ Church of Canada.

IBICA - International Brethren in Christ Association - an association of Brethren in Christ Churches from around the world.

MCC - Mennonite Central Committee - a global relief agency that serves as on behalf Be In Christ Church of Canada and other Anabaptist groups in responding to human need globally.

NCCS - Niagara Christian Community of Schools - A historic BIC school offering private Christian middle and high school education.

SRT - Senior Resource Team - The staff team of Be In Christ Church of Canada who provide day by day leadership to the work of the church.
